# Robert Bosch Electric Fuel Pumps, Fuel Pump Hanger Assemblies, Fuel Pump Modules and (Other Packaged Components) Limited Lifetime Warranty



Robert Bosch warrants all Electric Fuel Pumps, fuel pump hanger assemblies, fuel pump modules and (other packaged components) by Robert Bosch to be free of defects in material and workmanship for as long as you own the vehicle in which the electric fuel pumps, fuel pump hanger assemblies, fuel pump modules and (other packaged components) are installed, subject to the following terms and restrictions.

### **LIMITED LIFE TIME WARRANTY TERMS**

- I. As its sole obligation under this Warranty, Robert Bosch will replace the product free of charge to the purchaser as long as the purchaser returns the product to Robert Bosch or its sales channel affiliate along with the original bill of receipt and proof that the part was installed professionally.
- II. Warranty will be void if part was not supplied by Robert Bosch.
- III. Warranty will be void if Robert Bosch concludes at time of analysis of the part that the failure was due to contamination not limited to but including dirt, rust, or any other form of debris.
- IV. Robert Bosch will not be responsible for damage resulting from:
  - a. Installing part in an application it was not intended for as called out in a Bosch catalog or any other Bosch marketing and packaging material
  - b. Improper installation of a product where the user does not follow the Bosch written instructions or accepted industry standard
  - c. Alteration or modification of a product
  - d. Misuse, Neglect, Abuse, Accident
  - e. Failure to clean the fuel tank prior to installing new part
  - f. Failure to inspect the fuel lines
  - g. Failure to replace the inline fuel filter
  - h. Failure to replace the fuel filter/strainer on the fuel pump itself
  - i. Failure to replace tank seal/o-ring at time of replacement
- V. This warranty does not apply to any product that is installed in vehicles used for towing exceeding the vehicle manufacturer's defined limits, racing, public service, security or government use, off-highway recreational use, or four-wheel drive off-highway competition.

### **Warranty Claim Requirements**

To file a warranty claim with Robert Bosch for evaluation of suspected failure, please provide Robert Bosch and/or the sales channel affiliate with the following items: original bill of receipt, proof of new fuel filter installed – including receipt of new inline fuel filter installed, and the original product.

#### **Labor Claim Terms**

Robert Bosch will not be responsible for any cost or labor to remove and install a product or to restore a vehicle to its proper operating condition. Robert Bosch will not be held liable for any incidental or consequential damages under this warranty or any implied warranties, including, without limitation, towing charges, rental charges for a replacement vehicle, or loss of use of the vehicle.
